NEW – LEVEL 1 ONLY – ACTIVE DUTY Military Service, police officers, firemen, first responders receive 10% off the dues rate (does not apply to Food & Beverage Minimum) & have proper ID.

PLEASE READ THE SECTION BELOW BEFORE SIGNING APPLICATION:

All membership dues listed below have 5% SC admission tax included in the price.

ALL members are extended the courtesy of charging privileges and to earn loyalty points.

LEVELS 1 and 3 and STUDENTS do NOT pay public green fees but the following fees apply:

Level 1 & 3 adult members pay a daily \$2.00 user fee to walk--regardless of the # of holes played.

Cart rental is **NOT** included in the membership dues.

ALL members must have a valid driver's license to operate golf carts on our premises.

Level 1 & 3 cart rental for 9 holes is currently \$13 and \$19 for 18 holes (the \$2.00 user fee is included).

Privately Owned Carts must be registered in the office to operate on our course with the option to pay a monthly trail fee in addition to the membership dues OR pay regular member cart fees each use.

LEVEL 2-SOCIAL members pay the current posted public golf fees to play golf.

LEVELS 1-2-3 receive a 10% discount on merchandise and food & beverage items.

LEVELS 1-2-3 annual dues include a \$300 annual food & beverage allowance (monthly minimum to spend of \$25 for Level 1 & Level 2 and \$50 for Level 3. If the monthly food & beverage minimum is not spent each month the unused credit does not carry over to the next month.

LEVEL 1 – FULL - Includes ALL amenities–Golf, tennis, pickleball and summer swimming.

FAMILY – Applicant age 36+ and dependents. Annual Dues \$2,214 (\$184.50 per month)

FAMILY- JUNIOR – Age 19-35 and dependents. Annual Dues \$1,554 (\$129.50 per month)

SINGLE – Applicant age 36+, one person only. Annual Dues \$1,917 (\$159.75 per month)

SINGLE- JUNIOR – Applicant age 19-35. Annual Dues \$1,245 (\$103.75 per month)

LEVEL 2 – SOCIAL Includes tennis, pickleball & summer swimming-golf is not included.

FAMILY – Applicants age 19+ and dependents. Annual Dues \$ 837 (\$ 69.75 per month)

SINGLE – Applicant age 19+, one person only. Annual Dues \$ 690 (\$ 57.50 per month)

LEVEL 3 – CORPORATE – Same as FULL – for Applicant plus up to 5 employees.

Annual Dues \$4,200 (\$365.00 per month)

STUDENT / HIGH SCHOOL & COLLEGE RATES - Applicant Age 13-23

Student members do not pay the \$2.00 user fee when walking.

Student members pay \$13 for up to 18 holes to ride-must have a driver's license.

NEW STUDENT GOLF ONLY – Golf privileges only-walking rate.

Annual Dues \$ 252 (\$ 21.00 per month)

POOL/TENNIS SEASONAL MEMBERSHIP – OPENS MEMORIAL DAY THROUGH LABOR DAY

Membership includes use of the pool/clubhouse for the summer season only.

A one-time \$25 application fee is due when joining as a seasonal member for the first time.

RENEWALS: Family \$450 (Age 19+ immediate household dependents) Single \$325 (Age 19+)

NEW Applicant: Family \$525 + \$25 application fee Single \$350 + \$25 application fee
