MEMBERSHIP OPTIONS

LEVEL 1 - FULL - Golf, Tennis, Pickleball, and Pool - Single or Family

LEVEL 2 - SOCIAL - Same as Level 1 MINUS Golf - Single or Family

LEVEL 3 - CORPORATE - Same as FULL-plus up to 5 additional employees

INCLUDES:

- -Member account charging privileges full account due on the 10th of the following month.
- -10% discount on merchandise, food, and beverages in the Snackbar or Pro Shop.
- -\$25.00 (\$50.00 for Corporate) **monthly** food & beverage allowance. The \$25 (\$50 Corporate) food & beverage allowance is credited to your account on the last day of each month if you have spent at least that amount during the month on food & beverage. Drinks and snacks purchased in the pro shop also count towards the allowance. If you do not spend the minimum monthly amount the allowance will **not** carry over to the next month.
- -Loyalty points awarded for dues, carts, and golf merchandise; redeemable for discounts in the pro shop.

Club policies, amenity rules and loyalty point's information are attached for you to review. Golf:

- -Our 18 hole golf course is open year round (except on Christmas Day). Tee times are required for all golfers and can be made in advance by calling the pro shop.
- -Enjoy unlimited green fees; however, a \$2.00 user fee is required to walk or ride at any time 9 or 18 holes. The \$2.00 fee does not apply to **household dependent children under age 23**. User fees are budgeted to offset the club's annual property taxes.
- -A valid driver's license (age 16+) is required to operate our carts. Cart rental is not included in the club's membership dues. Per member rates are \$15 for 9 holes & after 4:00 pm / and \$20 for 18 holes (cart rates include the \$2 user fee + 7% SC cart tax).
- -Private carts are allowed for an additional monthly trail fee with proof of cart insurance.

Tennis / Pickleball:

- -Enjoy a clay tennis court and four asphalt Pickleball courts.
- -Call the golf pro shop at 843-873-2210 to schedule your court time.
- -You may bring guests to play tennis with you for a \$5.00 fee per guest. Thursday is our Member/Guest Special day bring up to 3 guests per member to play tennis free with you.

Swimming Pool –Open Memorial Day through Labor Day:

-The swimming pool is open for the summer season only at this time.

MEMBERSHIP TYPE / RATES (currently NO Initiation fees)

<u>Minimum payment</u> for LEVEL 1, 2, 3 or JUNIOR Membership is THE FIRST TWO MONTH'S DUES PLUS the Application Fee listed. 5% SC Admissions Tax included in rates. After the first year has been fulfilled, membership automatically renews on a monthly basis and must be cancelled in writing to stop the dues billing.

<u>DISCOUNT:</u> Deduct one month's dues AND application fee if paying for full year in advance.

<u>LEVEL 1 – FULL – Includes Golf, Tennis, Pickleball & Swimming Pool</u> <u>Application Fee \$100</u>

FAMILY - Applicant age 36+ plus household dependent family members.

Annual Dues \$2,214 (or \$184.50 per month)

FAMILY – JUNIOR – Applicant age 23 – 35 plus household dependent family members.

Annual Dues \$1,554 (or \$129.50 per month)

SINGLE – Applicant age 36+, one person only.

Annual Dues \$1,917 (or \$159.75 per month)

SINGLE – JUNIOR – Applicant age 23 – 35, one person only.

Annual Dues \$1,245 (or \$103.75 per month)

<u>LEVEL 2 – SOCIAL – Includes Tennis, Pickleball & Swimming Pool</u> Application Fee \$75

FAMILY – Applicant age 23+ plus household dependent family members.

Annual Dues \$837 (or \$69.75 per month)

SINGLE – Applicant age 23+, one person only.

Annual Dues \$ 690 (or \$57.50 per month)

<u>LEVEL 3 - CORPORATE – Same as FULL - For Applicant + up to 5 employees</u> <u>Application Fee \$250</u> Applicant accepts responsibility for their employees.

Annual Dues \$4,200 (or \$365 per month)

JUNIOR GOLF - GOLF ONLY - Applicant age 22 + under, per person Application Fee \$50 Food & beverage minimum not included.

No additional fee to walk. \$15.00 golf cart fee riding 9 or 18 holes - must be at least 16 with valid driver's license to drive carts. No cart rain-checks after 9 holes.

Annual Dues \$420 (or \$35 per month)

NEW JUNIOR SEASONAL DUES: \$150 per season (must pay in full)-choose season.

SEASONAL SUMMER POOL MEMBERSHIP - Open Memorial Day - Labor Day Membership includes use of the pool, tennis court and Pickleball courts during the summer season only. Full payment is due with application, 5% SC Admissions Tax included. Member charging privileges are allowed in the Snackbar during pool season only and are due by the 10th of each month. A statement of charges will be mailed to the address on file on the 1st of each month. Family applicants are responsible for their dependent's charges.

SUMMER POOL RENEWAL DUES: No Application fee for renewals.

FAMILY \$450.00 Applicant Age 19+, includes immediate household dependents.

SINGLE \$325.00 Applicant Age 19+, one person.

NEW SUMMER POOL APPLICANT DUES: \$25 Application Fee (added to rate).

FAMILY \$525.00 + \$25 Applicant Age 19+, includes immediate household dependents.

SINGLE \$350.00 + \$25 Applicant Age 19+, one person.
